During the transition period starting with the February 2007 elections, those elected President, Secretary, Membership & Activities served 2 years, but remaining four officers served for only one year until the 2008 election, at which point candidates for those offices ran for 2-year terms as well. (A proposal to add the position of President-Elect to the Board was tabled in 2006, to be considered at a future time.)

** Following election of JoElla John as President, Paul Hoecke Sr. relinquished the At-Large spot to Paul Dunlevy but was thereupon appointed by unanimous BOD vote to continue serving on the BOD in an ex-officio capacity as ad manager, parliamentarian, chapter archivist and historian.
